SHOW BREEDING QUALITY CONTRACT & AGREEMENT



The following is the contract and agreement between _____ -
purchaser, and The Scotia Kennel - breeder, regarding the purchase of a German Wirehaired

SECTION B:

Breeder's Guarantee:

1. The puppy is a purebred German Wirehaired Pointer registerable with the American Kennel Club papers provided. The breeder has determined this is a show/breeding quality puppy and guarantees that the puppy will meet the written breed standard provided by the AKC.
2. The puppy is free of internal and external parasites, and communicable diseases. The puppy has been appropriately medicated as indicated in the Health Record provided.
3. The puppy is guaranteed not to develop hip dysplasia or hypothyroid.
4. The Scotia Kennel guarantees that if the puppy fails to meet the above specifications, as shown by written diagnosis of a qualified veterinarian, it will resume ownership of the puppy and refund the purchase price. OR the breeder, upon proof of spay/neuter of the puppy, will replace the puppy

with a show/breeding quality puppy within two years.

5. If, on evaluation within two years, the puppy fails to meet the breeder's expectation of a show/breeding quality dog, the breeder will resume ownership of the puppy and refund the purchase price. OR the breeder, upon proof of spay/neuter of the puppy, will refund the purchase price difference between a show/breeding and non-breeding quality puppy from this litter. OR the breeder, upon proof of spay/neuter of the puppy, will replace the puppy with a show/breeding quality puppy within two years.

6. The Scotia Kennel agrees to waive its fee for providing AKC conformation handling of the puppy if the purchaser does not wish to show the dog personally. Purchaser will be required to pay entry fees and expenses.

7. The Scotia Kennel agrees to resume ownership of the puppy at any time if the purchaser is no longer able to care for the dog.

SECTION C:

Purchaser's Agreement:

1. Unless by written agreement, noted below, the puppy will not be bred before it achieves an AKC championship title and, at the very minimum, is NAVHDA tested for natural hunting ability or earns a Junior Hunter title.

2. The puppy will not be bred before being tested clear for hip dysplasia and hypothyroid. The puppy will not be bred to any dog, which is not a registered German Wirehaired Pointer, has limited registration or has not received the aforementioned health screening. Purchaser will provide the above information to the breeder before breeding the puppy. The breeder reserves the right to resume ownership of the dog, without providing any refund to the purchaser, if this clause is violated.

3. The puppy will be registered with **SCOTIAN** as a prefix to its name.

4. Purchaser will seek a veterinarian health exam within 72 hours of receiving the puppy in order to verify the puppy's health on arrival.

5. Purchaser will provide the puppy with the best care possible and strictly adhere to regular vaccination schedules and veterinarian check-ups. Any evidence of abuse, neglect or mistreatment, as defined by the breeder, is cause for automatic relinquishment of the dog to the breeder. Abuse, neglect and mistreatment, as defined by the breeder, include but are not limited to: muzzling for any reason other than emergency medical treatment, physical punishment which leaves scars, lack of human interaction for more than 12 hours a day on a regular basis, and more.

6. Purchaser agrees that the puppy will be returned to the breeder if, at any time during the course of the puppy's life, the purchaser is no longer able to care for the dog.
